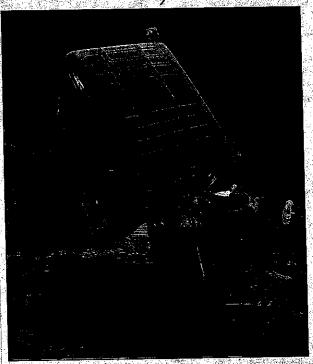

'Natural for child to not want to recall trauma'

NEW DELHE It is "highly natural" for a child to not want to recall the trauma of sexual assault and give varying accounts of the ordeal, a Delhi court said today while convicting a man of raping his 12-year-old neighbour, despite her changing statements.

The observation is in line with medical and on-ground findings, said experts, welcoming the judgment. "Any child who has undergone such a traumatic experience would not like to recapitulate the incident as it would be much go a step forward to damage her psyche in future," said the court.

The judge said it was only after sustained questioning that the girl said she gave varying accounts because she never wanted to remember the incident.

Clinical psychologist Dr Pulkit Sharma for Imago Centre for Self, said, "Most victims, when they undergo trauma, disassociate themselves from the event. That's why they don't have a very coherent recollection of such crimes

The court convicted one Ashok Jha on the basis of medical reports that confirmed rape.
